In fiscal year 2017-2018, 4 new homes were constructed in Rock Hill using energy efficient practices resulting in decent, affordable home ownership for 4 adults and 8 children. At the end of the fiscal year, in partnership with two families (2 adults and 6 children), construction in process was underway on 2 additional new construction homes - one in Rock Hill and one in York.

In fiscal year 2017-2018, a total of 33 home repair projects serving primarily elderly and disabled home owners and 3 community projects in support of neighborhood goals were completed. Home repairs and community projects occurred in York, Rock Hill, Clover, Lake Wylie and Fort Mill. Neighborhood revitalization and engagement activities within the Roosevelt, Oakridge, Paradise and Crawford Road neighborhoods were ongoing and will continue with a goal to work in partnership with 45 families in the next fiscal year.
