The ReStore operates two locations in York County - one in Rock Hill and one in Lake Wylie. Through ReStore operations hundreds of tons of furniture, building materials and household goods are diverted from the local landfill while providing an affordable avenue for bargain shoppers to acquire good, usable items for household needs and home improvement projects. Through ReStore program services, Habitat homebuyers-in-process may complete a portion of their program sweat equity service hours in the ReStore. In addition, the ReStore also contributes a valuable community service by providing the opportunity for workplace training and job skill development for adolescents and adults with special needs through partnerships with local schools and workforce training programs. In addition, the ReStore utilizes individuals with community service requirements to assist in daily operations as well as individuals temporarily assigned by their companies to complete light duty service while recovering from workplace injuries.

**Form 990, Part III, Line 4b - Program Service Accomplishments**

In fiscal year 2020-2021, the organization continued its Neighborhood Revitalization approach incorporating a spectrum of housing solutions through our Homeownership and Home Repair Programs along with ongoing neighborhood engagement and homeowner services.

Through the Homeownership Program, the affiliate completed 2 new construction homes in Rock Hill resulting in affordable homeownership with 2 adults and 2 children. Each home was constructed using energy efficient practices. Construction was in process on 2 additional new construction homes in Rock Hill by the end of the fiscal year with 2 families (2 adults and 7 children). During the fiscal year, there were a total of 17 homebuyer-in-process families (representing 19 adults and 42 children) in the Homeownership Program.

46 participants attended homebuyer orientation sessions and 752 individuals completed pre-homeownership/financial literacy sessions. The affiliate also serviced a total of 53 no-interest homeowner mortgages.

Through the Home Repair Program, the organization completed a total of 30 critical home repair projects (including 3 veterans) serving primarily senior citizens and/or disabled homeowners. 13 critical home repair projects were in process at the end of the fiscal year. Home repair projects were completed in Clover/Lake Wylie, Fort Mill, Rock Hill, and York.

Through our neighborhood engagement work, the organization partnered in 2 community-based projects and 2 community planning initiatives with the Crawford Road neighborhood (Rock Hill); 2 community-based projects in York; 2 community-based projects in the Roosevelt neighborhood (Clover). 6 of these community-based projects were COVID-19 first and second dose vaccinations clinics conducted in partnership with a local community health clinic resulting in 1,300 vaccines administered. In addition, the organization collaborated in 1 county-wide Thanksgiving food distribution project serving 150 households and Habitat homebuyers-in-process contributed 7,900 items to a local soup kitchen as a component of program sweat equity service.
